Introduction

Today I will present a special survey of the current state of History of Economic Thought (HET) at a world level, using my data base which includes calls for papers launched on international HET networks from 2012 to 2017 (in particular the SHOE list). This data base tells us essentially which world organizations "call" historians of economic thought to their conferences, and on which topics.

I will firstly look at the institutions (§ 1) and then at the titles (§ 2).

1. External history

In this section I will concentrate on institutions that have organised conferences and launched *calls for papers*, but will not examine the topics. The titles of the conferences are given however in order to distinguish between those with a title and those without.

3. Conclusions

We conclude by looking at a summary of the data with a few comments.

3.1. Conferences per year

Below I sum up the total number of conferences held per year. Remember that these are only the ones with calls for papers.

The first thing to notice is the enormous number! This makes us think about the extraordinary vitality of our discipline, despite the difficulty it has surviving inside the universities in various countries around the world. Or is this wealth of events perhaps caused by our academic problem, to compensate for the reduction of space in the university? And it also makes us think about the fact that the role of the Associations is fundamental. On this point, it is interesting to see which institutions are the most active today, apart from the territorial ones.

Among these, we notice the growing importance (and prevalence) of *networks*, in which geography no longer counts.

It is also interesting to think about how many non-HET organizations invite economic historians to participate in their conferences: as we have seen, they are institutions that include historians *tout court*, economists (of labour, development, law, etc.), econometricians, but also philosophers, scholars of political science and even of geopolitics.

Finally, we can say that today, always in different forms, it is still the institutions that play a central role: in continuity with the origin of our history, in the "Republic of Letters", it is still associations and international networks of scholars that ensure the dissemination and development of knowledge (Mokyr 2017).

3.2. Topics

The topics dealt with can be summed up as follows: single economists (in the broad sense) (23) economic crisis (12) formal history of economics (12) interdisciplinarity (or its aspects) (12) centre-periphery relationship (10) economic policy (role of the state) (9) foundations of economic theory (7)

thoughts on HET (5)
institutionalism (or role of the institutions) (4)
HET in general (4)
critique of political economy (3)
methodological issues (2)

Ex ante I did not expect to find so many conferences on single economists, and therefore on the reconstruction of both the sources of their thought and the context in which they lived, both their theory and their impact. It is especially this last aspect that seems to be dominant. It is a very broad, thorough approach, with no distinction between history of analysis and history of economic thought.

Conferences on formal history of economic theory would seem to be more numerous than those on general themes of economic thought, but the number is balanced out by the conferences on single economists and those offering reflection on the discipline.

I am not surprised however by the large number of conferences on the economic crisis: economic events and economic ideas often (though not always) march together, so also the reconstruction of the ideas is often done in parallel.

Many conferences concentrate on the relationship between Europe and the rest of the world, and in general on the theories of economic development; in my view it is a sign of the greater spread of HET in non-European countries, and of the focus on the specificities of their economic problems and their history.

A distinguishing factor in interpreting the economic theories of the past still remains that of economic policies, both from the standpoint of those advocating state intervention and from the standpoint of those who fear it. It is not surprising, because this division has always existed in economists' ideas, without interruption.

It is interesting to see that HET seems to provide an opportunity to think about interdisciplinarity. One wants to ask, like Trautwein (2017): are we really "the last generalists", faced with the specialistic fragmentation of the economist's profession?

Is HET still the home of critics of the mainstream? Let's add the conferences on single economists to those on single heterodox economists, to those that we have defined critiques of political economy, plus the conferences in the field of institutionalism, plus those on the foundations of political economy and on questions of method. The number is large, so I would say yes, it is, in the form of a pluralist reflection with different approaches. HET is therefore a place not only for reconstruction and contextualisation of the theories of the past, but also for a critical reflection on methods, on the foundations and contents of the discipline.

It is a rich, complex and pluralist picture of HET that I obtained by examining the conferences that have launched a *call for papers* on international HET sites in the

last six years. We have therefore identified all those who have reached out to historians of economic thought, inviting them to present HET work at their conferences from 2012 to 2017.
